#### Letter from the Nominating Committee

The 2024 Nominating Committee is grateful to all who provided recommendations and references, all who considered serving but declined, all whom the committee considered but did not nominate, and all who are nominated for service. We are also grateful for those who provided counsel and for all who have prayed on our behalf, faithfully and diligently, as we have worked throughout the year. While the Scriptures and the church's Bylaws are the foundation upon which we conduct our work, prayer is the framework. We are convinced that nothing can be or is accomplished according to God's will for his kingdom without calling on him continually and seeking the Spirit to guide and protect us. We ask the congregation to join us now in praying for these nominees and the leaders of Park Street Church.

The twelve committee members sought potential candidate recommendations for the role of elder from the congregation and the church leadership. We considered the potential candidates primarily as followers of Christ and then in terms of leadership together in this season of the church's ministry. We considered eligible incumbent elders together with other potential candidates, affirming their gifts and acknowledging their service to the church. The committee engaged in lengthy deliberations, prayed extensively over each potential candidate, and asked the Spirit to provide discernment and counsel in the selection of candidates for the role of elder. We had multiple conversations, spent hours discerning the candidates, voted, and reached a collective agreement. Throughout the entire process we called on God continually and trusted him to lead us. We trust that this is the slate that God led us to select for this term, and we now humbly submit the slate to you.

# Andrew Buckler, Candidate for Elder

- Andy became familiar with PSC through a substantial number of people who had common experiences between his former church membership and PSC. When deciding where to relocate both his residence and company location, Andy's desire to attend PSC was a central influence in choosing the location. Andy and his wife Betty began attending PSC in 2019 and joined in 2021.
- Andy shows a servant's heart having served in several church leadership positions at his former church (treasurer, stewardship committee, missions committee) and has participated in several Missions trips. Described as levelheaded, with a gift for planning and energy to persevere through extended periods of challenge.
- Andy is the founder of a Boston-based medical technology company using histology-validated software to provide physicians with a cost-effective means to optimize treatment. He has held multiple high-level corporate positions including Board of Director leadership and membership roles.

### Jake Lubinski, Candidate for Elder

- Jake started attending PSC in 2020. He felt a calling to serve at PSC and he and his wife were seeking a church where their children could grow in their faith. They found people at PSC who love Jesus. The church's witness and ministry to Boston and beyond led him and his wife to stay and join the church in 2022.
- Jake's strongest leadership skill is the ability to get a diverse team moving forward together toward accomplish a common goal. His spiritual gifts are wisdom, faith, service, and leadership. He has led a small group in his home and held a leadership position in his former church. He serves on both the PSC Facilities and F&A Committee.
- Prior to founding a software and insurance company, Jake led a portfolio of three medical device companies. As COO he led a team of over 100 employees.

# David Murgatroyd, Candidate for Elder (2<sup>nd</sup> term)

• David began attending PSC in 2000 and became a member in 2001. PSC's biblical teaching and commitment to missions showed David it was a place where he could plug in. David is committed to PSC and believes God can use him here.

- There are several areas where David has demonstrated his gift of leadership and teaching while serving PSC over the years (Café Leadership, Café Small Group Leadership, Nominating Committee, Elder (2008-2014 and 2022 to present), Personnel Committee, Nursery and Sunday School Leader, Senior Minister Search Committee.
- As an AI Director at a large music streaming services company, David describes himself as a "manager of managers." He leads a Christian resource group leadership team at work, served on the board of Park Street School, and serves on the Parent Resource Council of Lexington Christian Academy.

### Steven Weibley, Candidate for Elder (2<sup>nd</sup> term)

- After retiring from 35 years on staff at the same church (including Senior Pastor) Steve and his wife sought a church with "full counsel of God's word Gospel preaching." They found PSC during covid and joined in 2022.
- Steve has been a leader from his early days in Boy Scouts, as Chairman of the Board for New England Camp Cherith (now closed), taught at Christian Conferences, and directed music at Conservative Congregational Christian Conference (CCCC) annual meetings. In addition to serving on the PSC Board of Elders for the past year, Steve facilitated a 2024 PSC Lenten small group. He has seen fruit through this leadership.
- Although retired from full-time ministry, Steve is a professional educator and maintains a parttime teaching schedule directing vocal performance groups, teaching Latin, Classroom Music, and Drama.

# John Yee, Candidate for Elder

- John and his wife Mia first became members at PSC in 1998. The Biblical expository preaching
  and traditional style of worship were primarily what brought them to the church. In 2007, the
  Yees transferred to Highrock in Arlington to facilitate their young family's participation in
  youth activities. A job transfer sent them to PA in 2011 returning to MA in 2017. The Yee's
  began attending PSC again as churches reopened post COVID. Refreshed by the Gospelcentered preaching and music ministry, they reinstated their PSC membership in April 2023.
- John served on the PSC Board of Elders from 1999-2005, was instrumental in initiating All-Church Camp, and assisted as an usher. He has served as an AWANA group leader and has been involved in one of the community groups supporting an Afghan family relocated to Boston.
- A physician, John has spent over 25 years in various senior leadership roles at health care technology, biotechnology, and pharmaceutical companies.

The Nominating Committee generally re-nominates officers serving in the positions with a one-year term if they are willing to continue to serve. The committee aims to meet with each officer once per a three-year cycle. This year the committee met with Gabriel Ling and Debbie Gallagher.

# Gabriel Ling, Treasurer

- Gabe began attending PSC in 2004 and joined in 2009.
- He has served as Treasurer since 2020. He serves on the Board of Trustees at Park Street School and is on the Board of Advisors for the Boston Symphony Orchestra.
- Gabe is the co-founder and managing director of a venture and growth equity firm specializing in software. He is an accomplished pianist, and the congregation was recently blessed with a father-daughter performance as the worship service prelude.

### TREASURER OFFICER

The Treasurer (one-year term) oversees financial responsibilities for the church.

# Debbie Gallagher, Clerk

- Debbie has been a faithful part of the PSC community for 45 years, teaching the 3-year-old Sunday School class, participating in Women's Bible Study and Morning Prayer, serving on the Nominating Committee twice, the Interim Senior Minister Search Committee (Phil Thorne), and currently as Clerk.
- Debbie takes great delight in using her exceptional administrative skills and professional experience in her role as Clerk, taking seriously her duties as work done "unto the Lord". Enthusiastic about facilitating New Members Classes, she is especially blessed by hearing the faith stories of prospective members.
- She demonstrates a keen ability as a good listener, self-controlled, gentle, and peace-loving.

### CLERK OFFICER

The Clerk (one-year term) gives notice of and provides written record of the church's annual and special meetings. He or she also processes any membership-related correspondence.

### Andrew Buckler

"I came to faith in 1984 in a period of family crisis where Jesus both challenged and comforted me personally. From 1990 to 2019, my wife Betty and I gratefully called First Congregational Church of Hamilton (FCCH) our church home, where I served as treasurer and on the Missions Committee. I was privileged to have a variety of short-term mission experiences, such as distributing bibles to departing North Africans for Algiers and Tunis from the docks in southern Europe, and leading multiple groups in the aftermath of the breakup of Yugoslavia to help rebuild and reconcile Muslim, Orthodox, and Catholic combatants and their families. I have also visited church plants in North Macedonia and taught an electronics course for disadvantaged middle and high schoolers at a Rafiki orphanage in Ghana. In 2019, Betty and I came to downtown Boston to relocate a biomedical company I had founded, and we have enjoyed Park Street since then."

#### What are you currently excited about at PSC?

"I am excited about multiple things at Park Street. I am excited at the continuing sense of mission, with the opportunity to build on what those who have come before us have provided, and the privilege to continue in it. I am particularly excited in this moment to turn the page on last year's conflict, with the coming year focusing on what we should never lose sight of in providing a faithful witness in the city of Boston as the culture continues to change around us. Let us provide a message of hope to those who so desperately need us, supporting needs internally but also remaining faithful to the unique position God has placed our church in by being a visible and externally focused center for our city and our world."



### Jake Lubinski

"I grew up in a loving, Christian home with parents who modeled the power of faithfulness and prayer. I became a member of PSC in 2022 and have served on the F&A and Facilities Committees. Before attending PSC, I was on the Parish Council of my former church and led and hosted a small group for many years. My family and I have recently returned from several months of serving with missionaries in Uruguay. My professional background is in mechanical engineering and executive operations, and I have experience leading high functioning teams and restructuring and starting businesses. I live in Boxford, MA, with my wife, Caitlin, and two kids."

### What are you currently excited about at PSC?

"PSC is an incredible beacon of hope to Boston, a city that often feels like it has all but forgotten about Jesus. There have been recent challenges in our community, but these challenges also open up enormous opportunities for God to do a good work in us. I believe God is in our midst, redeeming our messiness and establishing his plans for this church. As an elder, I would be especially excited about supporting our staff, ministers and missionaries, and continuing to support Park Street's mission of sharing the gospel to our city and our world."



# Dave Murgatroyd\*

"God has used PSC's mission, teaching, and community to shape me for 25 years. My wife Amy and I met in Café in 2001 and are blessed with two daughters, Brenna (16) and Cora (14). I have served in various roles from the Board of Elders to HOME breakfasts for our unhoused neighbors, to DJ'ing the dance party at All Church Camp. I'm standing for reelection to the Board to seek God's guidance and to reflect it with greater clarity and compassion. May He make us one. (John 17:23)"

### What are you currently excited about at PSC?

"The last few years have been the hardest and saddest of my PSC tenure. But God doesn't waste anything. Remembering Romans 5:3-4, I have hope that he will not only rebuild for the years ahead but also redeem the years just behind us. I believe God can use PSC to bless Boston and the world in deeper and new ways and am excited to discern and pursue those together."



# Steven Weibley\*

"I married the love of my life in 1983 about a year after being converted from a non-believing, if religious, life in a non-believing family. In 1986, Deb and I left for Gordon-Conwell where I served as a Byington fellow. I joined the pastoral staff at Carlisle Congregational Church (CCCC) and remained at the same church until retirement. Further coursework included two terms at Cambridge University and studies at Reformed Theological Seminary where I studied with R.C. Sproul. I am a member of the Executive Council of the New England Reformed Fellowship and serve part-time as Latin, Music, and Drama teacher at the Imago School, where I have taught and spoken for morning chapel since the 1990's. Upon retirement, at Park Street my wife and I have found the blend we sought of gospel, biblical theological, expositional preaching and the "well-ordered" and joyful music."

### What are you currently excited about at PSC?

"During my decades of ministry in New England, I have been engaged with struggling churches and pastors and seen the same kind of hardship in our churches today as in the biblical churches; I know the immense value of staying the course for the sake of the gospel, however difficult. I found help in John Owen, the magisterial British Congregationalist who faced his own struggles with the assurance of the Scriptures. Reading Owen, I felt myself drawn in more deeply to understand the immensity and nearness of Who the Triune God is and how His Spirit changes my daily life and relationships with others. I am looking with anticipation to what the Lord may hold for us in the 2020's as we face our calling in Christ AND our disagreements with seriousness, patience, honesty, depth, love and delight."



### John Yee

"I accepted Jesus as my Lord and Savior in 1972, when I was 9 years old, at a summer Bible camp in rural Minnesota. I came to Boston in 1982 to attend college and stayed for my medical training. Mia and I met in college and were married in 1992. As newlyweds, we joined a PSC Bible study group and have been part of that group since then.
